Agreement and indemnity

That the Institute (its Officers, Directors, Employees, and Volunteers) will not be responsible or liable in connection with the accommodations or service of any means of travel, whether by aircraft, motorcar, motor-coach, or other conveyance which may be used wholly or in part in this program by me, nor will it be responsible for or assume liability for any injury, damage, death, loss, additional expenses, accidents, whatsoever, including defects in any vehicle, or through the acts or defaults of any company or person engaged in transporting me or in carrying out the arrangements of this program, or for losses or additional expenses occasioned directly or indirectly by the acts of God, delay or changes in schedules, overbooking or sickness, weather, strikes, war, quarantines, epidemics, pilferage, customs or immigration regulations or other acts or circumstances in this connection beyond the Institute's (its Officers, Directors, Employees, and Volunteers) control.
 2. All or any such losses and expenses as aforementioned will be borne by me and will be my sole responsibility.
 3. I FURTHER AGREE to release and forever discharge the Institute (its Officers, Directors, Employees, and Volunteers) from any and all action, causes of action, claims and demands for upon or by reason of any damage, loss or injury, to me and my property which may be sustained in consequence of the losses and expenses as aforementioned.
 4. I FURTHER AGREE TO INDEMNIFY and save harmless the Institute (its Officers, Directors, Employees, and Volunteers) against and from any and all claims and demand, actions, and claims for contribution or indemnify, whether under any statute or otherwise, which may be made or brought against the Institute (its Officers, Directors, Employees, and Volunteers), including the costs of defence of such action and claim.

The Institute (its Officers, Directors, Employees, and Volunteers) shall have the right to withdraw, or alter any such arrangements as it may deem fit and that no refund will be made to me by the Institute (its Officers, Directors, Employees, and Volunteers) for any unused portion of the exchange program's travel schedule.
